







Rules/Regulations

- CAR DECORATION AND/OR DISPLAY BOARDS are limited to Car Information, such as Year, History, or Nostalgic Era Theme Decorations only.
 NO POLITICAL DISPLAYS!
- CATEGORY/NUMBER CARD MUST BE PLACED ON WINDSHIELD OR DASHBOARD. Make sure it is visible, this is the information that is needed for judging.
