• **CAR DECORATION AND/OR DISPLAY BOARDS are limited to Car Information, such as Year, History, or Nostalgic Era Theme Decorations only. NO POLITICAL DISPLAYS!**

• **CATEGORY/NUMBER CARD MUST BE PLACED ON WINDSHIELD OR DASHBOARD. Make sure it is visible, this is the information that is needed for judging.**

• **DO NOT BLOCK A FIRE HYDRANTS, CROSSWALKS OR PARK ON THE CORNERS. You run the risk of legal action and will be towed. IF WE CAN'T FIND YOU TO HAVE YOU MOVE YOUR CAR, THE SNOHOMISH COUNTY SHERIFF'S DEPARTMENT WILL NOT HESITATE TO TOW YOUR CAR.**

• **"BIG RIGS" and Large Entries measuring over 20' will be parked on 1st St. East of Union to Maple.**

• **IF YOU'RE TRAILERING YOUR VEHICLE, you NEED to be preregistered and contact the Chamber at 360-568-2526 for instructions.**

• **PARK AS INSTRUCTED BY PARKING CREW FAILURE TO COMPLY WITH Barricade Security, Sheriff's Department, or Parking Crew could result in EXPULSION OR REMOVED FROM JUDGING.**
